



CODE OF CONDUCT & TERMS AND CONDITIONS

Your attention is drawn to the following which you must read and understand prior to participating in Skateboarding at the Warehouse Indoor Skatepark (the “Activity”). You further accept that you have had the opportunity to seek clarification from Skateboard Cambridge CIC on any of the following points.

Please take a moment to read and familiarise yourself with our Code of Conduct & Terms and Conditions.

1. You must **REGISTER** using the online form before using the facilities at the skatepark.
2. By purchasing entry to the Activity you are agreeing to these Terms and Conditions and you are declaring you are fit to participate, and by participating you accept the serious risk of injury and potentially death, and you agree to accept responsibility for your own actions and involvement.
3. Under 16 year olds **MUST** have consent from a parent or guardian.
4. Under 12 year olds **MUST** be accompanied by a parent or guardian (unless participating in an event managed by a qualified instructor).
5. Helmets are mandatory for all under 16 year olds
6. Minimum standards of conduct apply including, but not limited to, controlling your speed, not behaving in a way that endangers or alarms others, using the equipment safely and respecting all signage and safety rules. Skateboard Cambridge CIC reserves the right to require you to leave the premises if you are deemed by a Skateboard Cambridge CIC officer not to be meeting reasonable standards of behaviour. In such cases, no refund will be given.
7. Skateboard Cambridge CIC reserves the right to refuse admission to any person on any grounds. Anyone who is visibly intoxicated or drunk shall not be permitted to participate and in such cases, no refund will be given.
8. Alcohol must not be consumed on the premises or before entry to the park.
9. Anybody deemed intoxicated will not be allowed to enter the park.
10. Drug use or possession will not be tolerated.
11. If you observe a hazard or damage or are injured whilst using Skateboard Cambridge CIC facilities you must bring this to the attention of an officer or employee immediately.
12. All of your equipment must be in good working order with no loose parts.
13. No sitting on ramps/obstacles.
14. Spectators must stay in designated areas and must not climb on any ramps.
15. No food or drink to be consumed on the ramps.
16. Vandalism will not be tolerated.
17. No Spitting.
18. Bullying or violence of any kind is strictly forbidden.
19. Do not open any of the fire doors for any reason other than in the event of a fire.
20. Theft from the park or other users will not be tolerated. Neither Skateboard Cambridge CIC nor its employees or agents shall be responsible for any loss, theft or damage to valuables or any personal property that belongs to any person whilst on the Activity premises.
21. Smoking will not be tolerated anywhere within the premises.
22. An accident book is available and any injury to a user should be reported to a member of staff.
23. In the absence of negligence or fraudulent misrepresentation committed by Skateboard Cambridge CIC, their employees, officers, officials or agents, these Terms and Conditions hereby exclude to the fullest extent permitted by law all responsibility and liability for the death, personal injury or illness of any person whilst present on the site.
24. Skateboard Cambridge CIC reserves the right to change its policies from time to time.

Important Participant Information

There is a serious risk of injury and potentially death from the activities and services offered by the Activity.

1. You engage in the activities at your own risk.
2. We strongly recommend satisfactory safety equipment to be worn by all participants including helmets, wrist guards and knee pads.
3. If you engage in the activities without a protective helmet then you do so at your own risk.
4. You are advised that using our facilities without wearing a full set of protective gear increases the risk of personal injury and death in the event of an accident.
5. Please note that the activities are not recommended for persons who have heart, back or neck conditions, or people who are pregnant. If you suffer from any health problems, illness or may be pregnant please consult your doctor for medical advice before participating in the Activity.
